Food Grade Molasses

Description

A black, viscous liquid which is the final product remaining after all commercially available sucrose has been removed from sugar syrup. Molasses appears black to reddish brown (when aerated) and the odour and flavour are typically strong of caramelised sugar. The molasses has been further treated to ensure it meets food grade requirements

A common ingredient in the baking and confectionery industries

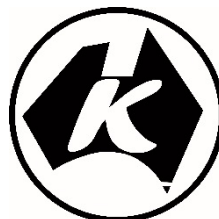
